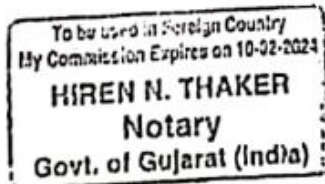

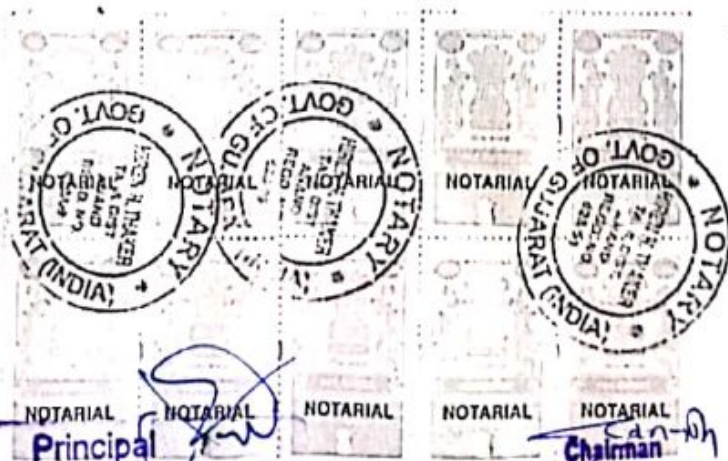

2. In connection with rule 106 (2) and 112(2) (4) of Mumbai primary education rules 1949 the provisions of schedule (F) will have to be strictly implemented
3. Education will have to be imparted by recruiting qualified trained teachers in accordance with rules.
4. As per provision of rule 106 (K) (11) of Mumbai Primary Education Rules 1949 the managing committee will have to open an account with the scheduled bank for payment of salary of the teachers. The payment of the salary will have to be done by depositing money through cheque in their book bank accounts.
5. As per shown in para 1 there should be rooms having sufficient area as per rules, play ground, physical facilities, health related facilities, airy building library furniture equipment's in sufficient proportion in all the schools.
6. The syllabus approved by the government will have to be observed as per detailed subject and education will have to be imparted from the text books approved or made or determined by the government from time to time.
7. All the provisions, orders etc made / determined by the government from time to time will have to be followed.
8. If the conditions determined for the permission are not observed, the permission of the school will be withdrawn back in connection with the provision of rule 109(2) of Mumbai primary education rules 1949.
9. If the school is not started in the year of permission at the place shown in the order of the permitted school the permission will stand liable to be automatically cancelled.
10. As per the resolution no PRE-1111-711=K dated 27-04-11 of the education

department of the government, the recruitment of candidate having passed

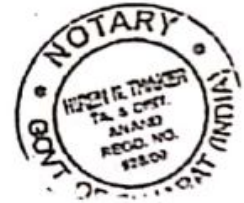

6. The syllabus approved by the government will have to be observed as per detailed subject and education will have to be imparted from the text books approved or made or determined from time to time
7. All the provisions, orders etc determined / made by the government from time to time will to be followed.
8. If the conditions determined for the permission are not observed the permission of the school will be withdrawn back in connection with the provisions of rule 109 (2) of Mumbai Primary Education Rules 1949.
9. If the school is not started in the year of permission at the place shown in the order of the permitted school, the permission will stand liable to be automatically cancelled.
